Foundation Governor - Chair of Governors – Dr Peter Goodwin

Dr Goodwin is a Senior Lecturer in Physiotherapy at Manchester Metropolitan University and University of Manchester. He has board level experience in higher education and charity sectors. His experience in education and research provides an excellent background for the role of governor.
